Everything Mailboxes

ave you noticed how spectacular the new mailboxes look throughout the neighborhood? To date, 201 residents have installed these distinctive new mailboxes. Real estate agents, home buyers and neighbors have all shared that these mailboxes are a wonderful improvement and increase the appeal of our neighborhood.

If you have not replaced your mailbox, you have until the end of the year to do so. Many residents have asked the board to give more attention to remaining preexisting mailboxes that are in great need of attention. Therefore, beginning in April, our management company will start inspections of the older-style mailboxes and mail out violation letters to residents whose mailboxes are in a state of disrepair.

If you have a pre-existing mailbox, please ensure the following to avoid a violation letter:



- No chipping/flaked paint.
- If your mailbox has a pineapple, it must be painted gold.
- For mailboxes with brass numbers: they must all be present and polished to show the brass color.
- For mailboxes with sticker numbers: they must be reflective, not peeling and a uniform size.
- Doors must be hinged and attached, and open/close properly. They cannot be held on with wire.
- All parts must be present.
- The mailbox must be dent free.

For those who have not purchased the new mailbox, your neighbors would be very appreciative if you ordered it as soon as possible. one year to complete.



Helpful Springtime Reminders

Springtime in Waterside usually brings lots of home improvement activity. The Board would like to provide you with these friendly reminders as we enter this busy season.

- ♦ Lawn Care. Bermuda grass is what is allowed in Waterside. It needs to be mowed and trimmed 3 to 4 times a month during the spring and summer months.
- ★ Tree Care. Trees cannot be removed without City approval. For more information, see the Remove a Tree link on our website (under "Architecture").

Bushes and Flowerbeds. Please keep your shrubs and flowerbeds trimmed and mulched. Well-maintained bushes not only look nice, but keep you safe. Large bushes around windows are ideal spots for "bad" guys to hide. In addition, overgrown hedges provide bugs an opportunity to enter into your home. So many reasons to dust off those clippers!

✦ Home and Property Changes. Are you thinking about changing out your fence, adding on to your deck, installing new landscape lighting, or updating your paint? Before making these modifications, you must complete the request form(s) found on the "Architecture" section of our website. Unapproved modifications may result in reversing those changes at your expense. The board has 60 days to respond to your request, so please plan accordingly. You should not begin work until you have received approval. The board strives to turn around requests VERY quickly and usually does so in the same week as the request.
